The administration reserves the right to contact the police at any time, hold conferences with parents and/or teachers, ask for written letters of apology, and/or community service if applicable. Where other regulations exist with regard to discipline, those regulations will supersede the discipline code. When a discipline matter is referred to the office, the administration will make the determination of what appropriate consequence will be applied.
